MIAMI LIGHTHOUSE CELEBRATES 95th ANNIVERSARY

Miami Lighthouse marked an historic milestone of 95 years of service at our Diamond Anniversary Celebration held on January 27th at the historic Biltmore Hotel in Coral Gables.

The sold-out crowd of community leaders and philanthropists heard President and CEO Virginia Jacko speak about the Board of Directors' commitment to sustain and grow Miami Lighthouse for another 95 years. She announced a two-year campaign to raise \$9.5 million to sustain our legacy of transforming the lives of the blind and visually impaired, from blind babies to seniors. A "Matching Challenge Team" of philanthropists has already committed \$4.5 million to match additional donations to Miami Lighthouse. US Blind Soccer Comes to Miami Lighthouse

More than 150 participants took part in the USA Blind Soccer-Kickoff for Inclusion event on February 24, hosted by the U.S. Association of Blind Athletes (USABA) in collaboration with the Anthony R. Abraham Foundation and Miami Lighthouse for the Blind. Attendees of all ages had the opportunity to meet athletes from the first-ever USA Blind Soccer Men's National Team, view a blind soccer demonstration and most importantly try the sport of blind soccer for themselves. They also met Oseas De Leon, a USABA developmental athlete who serves as Senior

Technology and Braille Specialist at Miami Lighthouse, Thomas Abraham with USA Blind Soccer Men's National Team who has been playing blind soccer since he was

three years old. Oseas is now competing to be selected for the US National Team and was recently featured on WSVN-7 Spotlight. Assisting with the day's demonstrations were coaches and players from the Barry University and Christopher Columbus High School soccer teams. "Building Blind Soccer" sites, under the auspices of U.S. Soccer's "Innovate to Grow" grant to expand the sport at the grassroots level, have already been established in Los Angeles, Chicago, New York, Dallas, Columbus, Charlotte and Baltimore.

"It's Possible to See ART without Sight"

With support from the Wildflower Foundation matching grant, our talented artists, despite their vision loss, continue to receive recognition and awards in local, regional and national art competitions. The instruction provided by the professional staff in our tactile arts program empowers participants in our Senior Group Health and Activities Program (SGA) and students in our academy to excel artistically. Their achievements are a testament to the artistic environment we are committed to fostering, reinforcing Miami Lighthouse's teaching that "It's Possible to See ART Without Sight."

"Hands of Hope," a mixed media painting created by children in our Miami Lighthouse Academy was displayed in the Florida State Capitol Rotunda in Tallahassee during the annual Children's Week "Celebration of the Hands." Academy art students' handprints on the 36" x 36" painting are decorated in colors of gold, purple, blue and yellow and are texturized with puffy paint, glitter, and gems. Children's Week Florida™ is the largest event held in the state that celebrates and honors its commitment to children, youth, and advocates. The children's art serves as a daily reminder to legislators and visitors that the future of our children rests in their hands. We were honored that "Hands of Hope" was featured in a Children's Week email blast that was sent to

We are the only organization in the nation offering all-inclusive music, audio instruction, and development programs for the blind and visually impaired of all ages. Miami Lighthouse provides the only Braille music distance learning curriculum, which is accessible from anywhere in the world. Daniel Solomon's parents brought him to Miami Lighthouse as a young child when he was diagnosed with ocular albinism. Daniel has never let his disability keep him from living a productive life. He graduated summa cum laude from Palmetto Senior High School, was a 2022 Silver Knight Award recipient, and was accepted to his first college of choice, Brown University.

Daniel attributes the training he received at Miami Lighthouse to be the foundation for his ability to succeed in life. In recognition of the importance of programs specifically designed for the visually impaired such as those offered by Miami Lighthouse, he has worked with Brown University to develop initiatives to bridge the gap between education and inclusivity for the blind. He proposed and now co-teaches a course entitled "Blindness, Arts, and Media" at Brown's School of Public Health. Daniel said in the *Miami Herald* article, "For the majority of students, this was the first time they were ever exposed to learning about blindness in their daily lives, urging them to think critically about how their actions impact the blind community." Daniel is the co-founder and and president of Blind@Brown, Brown's association of blind and visually impaired students.

Cortical Visual Impairment Collaborative Center Update

Our Miami Lighthouse Cortical Visual Impairment Collaborative Center is Florida's first collaboration between medical professionals, educators, researchers and service providers responding exclusively to CVI, and we want to share with you an overview of our progress and achievements.

- Our CVI Collaborative Center collaborators include Bascom Palmer Eye Institute, Nicklaus Children's Hospital, Perkins School for The Blind, Miami-Dade County Public Schools Office of Exceptional Learners, and NSU College of Business and Medicine for Data Analysis. We and our collaborators have made significant headway including a research protocol for the medical diagnosis of CVI, infant screening protocols in NICU and PICU settings and assessment and rehabilitation practices.
- In 2023, our CVI Collaborative Center received the coveted Greater Miami Chamber of Commerce Nonprofit Business Innovative Excellence Novo Award.
- Our CVI Collaborative has hosted four professional development workshops led by experts in
 the field and in furtherance of our goal to establish our CVI Center as the national leader for
 best practices in CVI education, screening, diagnosis, intervention and research, and we were
 invited to make presentations at five professional conferences, three in Florida and two
 nationally.
- In-service training and lunch-and-learns were completed for professionals and optometrists at Nicklaus Children's Hospital, an Early Learning Coalition Provider Meeting, Miami Vision Therapy and Optometry, United Way Center for Excellence, ICU Baby and a Miami Dade Optometric Physicians Association continuing education event.
- As a result of our community outreach, in-services, professional development workshops, CEU presentations, and ongoing support for families and children with CVI in the community, we have seen an increase in awareness and interest in CVI which has led to a growth in the number of referrals.
- We have provided CVI-specific assessments and comprehensive reports on educational interventions for all children referred to our CVI Collaborative Center. Since 2020, we have completed 160 CVI children's assessments. These assessments are of utmost importance because functional vision in such children can be expected to improve with appropriate intervention.
- We continue to refine and grow our database by collecting information on the children assessed by our CVI Collaborative Center such as referral source, demographics and ethnicity, diagnosis, pre- and post-assessment data and other pertinent data in order to support CVI research efforts in service delivery, diagnosis, intervention, and evaluation.





Dr. Murray Heiken passed away on March 12, 2024. Our Florida Heiken Children's Vision Program was founded in 1992 by the Miami-Dade Optometric Physicians Association as the Dr. Bruce Heiken Memorial Fund in memory of their colleague, Dr. Bruce Heiken, Murray and Rosalyn Heiken's son, who frequently provided free eye care to children.

The Heiken Fund was Florida's first program providing free eye care and eyeglasses to children without other access to vision care. Since its inception, the Heiken Program has provided over 203,500 comprehensive eye exams and more than 147,600 prescription glasses at no cost to financially disadvantaged schoolchildren throughout the state.


